

You need to correct the errors or warnings in the migration template before you can continue with the import process. The Convert Values stage is where the system converts values from external formats to internal formats, such as currencies, units of measure, or date formats. The Validate Data stage is where the system validates the data against predefined rules and checks for any inconsistencies or errors. The Execute Import stage is where the system imports the data into SAP S/4HANA Cloud after passing all previous stages.
